Dear ACM Members, Associate Members, & Friends,

With only two weeks left until Election 2010, our industry must rise up and communicate with all the candidates for the Minnesota Legislature about the future of Charitable Gambling in Minnesota. With all of the election talk about budget deficits we are continually hearing about racinos, state owned/operated casinos, and video lottery terminals run by the Minnesota State Lottery. Charitable Gambling is certain to be adversely affected by any or all of this additional gambling if we don't push our own agenda.

Right now our industry is stagnating and is in crisis. We need to be moving forward and pushing aggressively to update our current games if Charitable Gambling is to remain a viable and effective community-based fund-raising activity in the future. **In addition, with a projected \$6 billion deficit we could very well end up being a target of the "sin tax" syndrome and find ourselves fighting off additional Charitable Gambling tax increases in the next legislative session.**

We need these candidates and would be legislators to help reinvigorate and modernize our current games (i.e. - electronic linked bingo and/or electronic pull-tabs) within the existing Charitable Gambling structure. We also need a less onerous Charitable Gambling tax system. ***By updating our current games and utilizing 21st century technology we can bring about much needed Charitable Gambling tax reform and relief that is revenue neutral for the State of Minnesota.*** This would allow us to keep more funds in our local communities for the worthy programs and projects we support throughout Minnesota.

During the next few weeks prior to the November 2, 2010 election we need Charitable Gambling organization & company members & employees to contact their local Minnesota Legislative candidates and make the following points:

- *Charitable Gambling organizations SUPPORT updating and modernizing our current games utilizing 21st century technology within the current Charitable Gambling structure which will allow for Charitable Gambling tax reform and relief that is revenue neutral for the State of Minnesota.*
- ***Charitable Gambling organizations OPPOSE any increases in Charitable Gambling taxes.***
- *Charitable Gambling organizations OPPOSE the elimination or replacement of paper pull-tabs or paper bingo.*

At the very least we need the CEO & Gambling Manager of every licensed organization to contact the local candidates in their area. We need to make sure that the candidates that get elected on November 2nd have heard from their local Charitable Gambling organizations. Enclosed are several copies of the CY 2009 ACM Charitable Gambling Fact sheet which you can use to show that Charitable Gambling in Minnesota has stagnated and is indeed in crisis. **Please take the time to contact the local candidates in your area so that we can enhance, protect, and preserve Charitable Gambling to ensure the numerous programs and projects we support in our local communities are not endangered.**

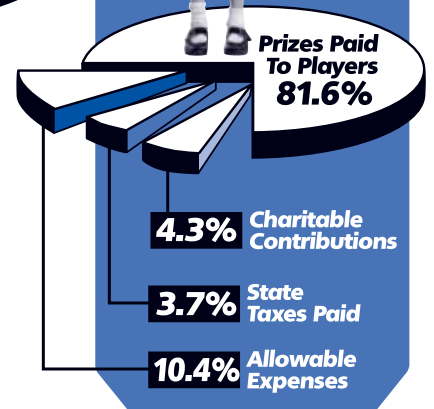

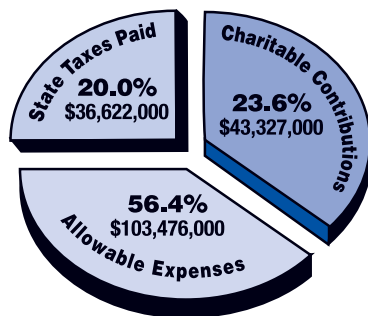

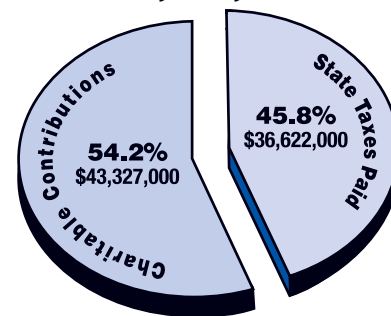

An Open Letter to Legislative Candidates

Support Charitable Gambling - A Community Resource!

Charitable gambling in Minnesota is in crisis! We are hurting and we need your help at the state Capitol.

Charitable gambling sales are at their lowest point in a decade and last year charitable contributions were at an all time low. In fact, charitable contributions have dropped 57% from a high of over \$101.2 million to \$43.3 million last year.

All this bad news at a time when licensed non-profit charitable gambling organizations are receiving more local requests for donations than ever before. The local needs are great, but unfortunately charitable gambling efforts have not been able to keep up with the needs of our local communities. In fact, we have been losing ground to the point where many charities have terminated their charitable gambling licenses.

This critical community resource is slowly disappearing.

We need your help to reinvigorate and modernize our current games (pull-tabs, bingo, paddlewheels, raffles, & tipboards) within the existing charitable gambling structure to allow us to regain a strong foothold in our communities. We also need a less onerous charitable gambling tax system. ***By updating our current games and utilizing 21st century technology we can bring about much needed charitable gambling tax reform and relief that is revenue neutral for the State of Minnesota.*** This would allow us to keep more funds in local communities throughout Minnesota to support veteran programs, youth activities, food shelves, and other programs too numerous to mention.

In any case, Allied Charities of Minnesota does not support the elimination or replacement of paper pull-tabs or paper bingo with electronic gaming devices at our licensed sites. We also do not support racinos, state owned/operated casinos, or video lottery terminals run by the Minnesota State Lottery, all of which would adversely affect charitable gambling in Minnesota.

Charitable gambling interests need to be at the table during any serious discussions at the state Capitol about additional gaming in Minnesota.

Allied Charities of Minnesota encourages you to seek out your local charitable gambling organizations and talk with them about our plight. Hear first hand from them what is happening in your communities.
