GCB 2009 Charitable Gambling Policy Bill Introduced

On Monday, March 9, 2009 the *Gambling Control Board's 2009 Charitable Gambling Policy Bill* was introduced in the Minnesota Senate (**SF 1284**) and the Minnesota House of Representatives (**HF 1511**). This bill is primarily based on the Gambling Control Board's 2009 Lawful Gambling Study that was released on February 2, 2009 (amended 3/2/09). A copy of the GCB Study will be mailed out to all 2008 ACM Members & Associate Members by the end of the week.

SF 1284 was referred to the Senate State and Local Government Operations and Oversight Committee. **HF 1511** was referred to the House Commerce and Labor

2009 Gambling Bill Introductions

Listed below are the 2009 gambling bills introduced since the 2.14.09 ACM Legislative Update (thru 3/9/09):

Senate File (SF) 719 (Hann; Vandever; Limmer) - State gambling facility (casino) location voter approval requirement. (*Companion to HF 395*)

SF 789 (Sparks; Tomassoni; Metzen; Wiger; Koering) - Video pull-tab games gambling control board rules adoption requirement. (*Companion to HF 502*)

House File (HF) 832 (Lenczewski; Rosenthal; Slocum) - Bloomington; State-operated or state-licensed gambling facilities prohibited unless approved by voter referendum.

SF 950 (Day; Rosen) - Lottery gaming machines (racino). (*Companion to HF 633*)

SF 1053 (Lourey; Marty; Robling; Kubly; Koering) & HF 1098 (Anzelc; Brod; Abeler; Zellers; Fritz; Atkins) - Compulsive gambling public awareness and education funding provided, and money appropriated.

HF 1082 (Beard; Buesgens; Anzelc) - Occupational licenses provided.

SF 1096 (Moua; Olson, M.) & HF 1171 (Jackson) - Revisor's bill.

SF 1284 (Lourey; Rest; Robling; Gerlach) & HF 1511 (Atkins; Zellers; Anzelc; Brown; Dill) - Lawful gambling and gambling board provisions modifications. (*GCB Bill*)

SF 1291 (Michel) & HF 1486 (Brod) - State agency services privatization potential review requirement and state owned assets database preparation.

HF 1303 (Hackbarth) - Casino authorization proposed, gambling revenue tax imposed, construction provided for a new Vikings stadium, bonds issued, and constitutional amendment proposed.

HF 1406 (Dill; Atkins; Zellers; Brown; Davids; Anzelc; Howes; Hackbarth; Doty) - Lawful gambling tax provisions modified. (*ACM Bill*)

HF 1420 (Nornes) - Racetracks allowed outside of the seven-county metropolitan area, and racetracks allowed to operate card clubs.

HF 1512 (Atkins; Dill; Zellers; Brown; Davids; Anzelc; Howes; Bigham; Hackbarth; Doty) - Electronic bingo authorized, pull-tab dispensing devices modified, clarifying and conforming changes made. (*ACM Bill*)
