1.3 and other regulatory provisions; making changes to expenditure restrictions;
1.4 modifying games and prizes; making clarifying, conforming, and technical
1.5 changes to lawful gambling; requiring a report; amending Minnesota Statutes
1.6 2006, sections 349.12, subdivisions 18, 31; 349.15, by adding a subdivision;
1.7 349.161, subdivisions 1, 5; 349.1641; 349.167, subdivisions 2, 4, 7; 349.17,
1.8 subdivision 7; 349.18, subdivision 1; 349.19, subdivision 10; 349.191,

1.12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.13 Section 1. Minnesota Statutes 2006, section 349.12, subdivision 18, is amended to read:

1.14 Subd. 18. **Gambling equipment.** "Gambling equipment" means: bingo hard cards
1.15 or paper sheets, linked bingo paper sheets, devices for selecting bingo numbers, electronic
1.16 bingo devices, pull-tabs, jar tickets, paddlewheels, paddlewheel tables, paddletickets,
1.17 paddleticket cards, tipboards, tipboard tickets, promotional tickets that mimic a pull-tab or
1.18 tipboard, and pull-tab dispensing devices.

1.19 Sec. 2. Minnesota Statutes 2006, section 349.12, subdivision 31, is amended to read:

1.20 Subd. 31. **Promotional ticket.** A pull-tab or tipboard ticket created and printed by a
1.21 licensed manufacturer with the words "no purchase necessary" and "for promotional use
1.22 only" and for which no consideration is given is a promotional ticket.

1.23 Sec. 3. Minnesota Statutes 2007 Supplement, section 349.15, subdivision 1, is
1.24 amended to read:

2.1 Subdivision 1. **Expenditure restrictions.** Gross profits from lawful gambling
2.2 may be expended only for lawful purposes or allowable expenses as authorized by the
2.3 membership of the conducting organization at a monthly meeting of the organization's
2.4 membership. Provided that no more than 70 percent of the gross profit from bingo, and
2.5 no more than 60 percent of the gross profit from other forms of lawful gambling, may
2.6 be expended biennially during the term of the license for allowable expenses related to
2.7 lawful gambling, except that for the period of July 1, 2008, to June 30, 2009, no more
2.8 than 75 percent of the gross profit from bingo, and no more than 65 percent of the gross
2.9 profit from other forms of lawful gambling, may be expended for allowable expenses
2.10 related to lawful gambling. For licenses issued after June 30, 2006, compliance with this
2.11 subdivision will be measured on a biennial basis that is concurrent with the term of the
2.12 license. Compliance with this subdivision is a condition for the renewal of any license
2.13 beginning on July 1, 2008. For licenses renewed with an effective date between July 1,
2.14 2006, and June 30, 2008, an organization shall carry forward an amount equal to 15
2.15 percent of any positive allowable expense carryover amount. This balance must be used to
2.16 offset any future negative expense balance at the time of license renewal.

2.18 to read:

2.19 Subd. 5. **Civil penalty.** (a) If an organization exceeds the expense limitation
2.20 contained in subdivision 1, the board may suspend the organization's license or impose a
2.21 civil penalty as follows:

2.22 (1) up to five percent of the reimbursement amount for the first violation;

2.23 (2) up to ten percent of the reimbursement amount for a second consecutive
2.24 violation; and

2.25 (3) up to 25 percent of the reimbursement amount for subsequent consecutive
2.26 violations.

2.27 (b) In determining any suspension or penalty for a violation of subdivision 1, the
2.28 board must consider any unique factors or extraordinary circumstances that directly
2.29 caused the organization to exceed the expense limitation. Unique factors or extraordinary
2.30 circumstances include, but are not limited to: the purchase of capital assets necessary to
2.31 conduct lawful gambling; road or other construction causing impaired access to the lawful
2.32 gambling premise; and flood, tornado, or other catastrophe that had a direct impact on
2.33 the continuing lawful gambling operation.

2.34 (c) Notwithstanding section 349.151, subdivision 4, paragraph (a), clause (10), the
2.35 board may impose a civil penalty under this subdivision that exceeds \$500.

3.4 than for lawful gambling exempt or excluded from licensing, except to an organization
3.5 licensed for lawful gambling;

3.6 (2) sell, offer for sale, or furnish gambling equipment for use within the state
3.7 without having obtained a distributor license or a distributor salesperson license under
3.8 this section except that an organization authorized to conduct bingo by the board may
3.9 loan bingo hard cards and devices for selecting bingo numbers to another organization
3.10 authorized to conduct bingo;

3.11 (3) sell, offer for sale, or furnish gambling equipment for use within the state that is
3.12 not purchased or obtained from a manufacturer or distributor licensed under this chapter; or

3.13 (4) sell, offer for sale, or furnish gambling equipment for use within the state that
3.14 has the same serial number as another item of gambling equipment of the same type sold
3.15 or offered for sale or furnished for use in the state by that distributor.

3.16 (b) No licensed distributor salesperson may sell, offer for sale, or furnish gambling
3.17 equipment for use within the state without being employed by a licensed distributor or
3.18 owning a distributor license.

3.20 Subd. 5. **Prohibition.** (a) No distributor, distributor salesperson, or other employee
3.21 of a distributor, may also be a wholesale distributor of alcoholic beverages or an employee
3.22 of a wholesale distributor of alcoholic beverages.

3.23 (b) No distributor, distributor salesperson, or any representative, agent, affiliate, or
3.24 other employee of a distributor, may: (1) be involved in the conduct of lawful gambling
3.25 by an organization; (2) keep or assist in the keeping of an organization's financial records,
3.26 accounts, and inventories; or (3) prepare or assist in the preparation of tax forms and other
3.27 reporting forms required to be submitted to the state by an organization.

3.28 (c) No distributor, distributor salesperson, or any representative, agent, affiliate,
3.29 or other employee of a distributor may provide a lessor of gambling premises any
3.30 compensation, gift, gratuity, premium, or other thing of value.

3.31 (d) No distributor, distributor salesperson, or any representative, agent, affiliate, or
3.32 other employee of a distributor may provide an employee or agent of the organization
3.33 any compensation, gift, gratuity, premium, or other thing of value greater than \$25 per
3.34 organization in a calendar year.

4.5 (f) No distributor, distributor salesperson, or any representative, agent, affiliate, or
4.6 other employee of a distributor may alter or modify any gambling equipment, except to
4.7 add a "last ticket sold" prize sticker.

4.8 (g) No distributor, distributor salesperson, or any representative, agent, affiliate, or
4.9 other employee of a distributor may: (1) recruit a person to become a gambling manager
4.10 of an organization or identify to an organization a person as a candidate to become
4.11 gambling manager for the organization; or (2) identify for an organization a potential
4.12 gambling location.

4.13 (h) No distributor or distributor salesperson may purchase gambling equipment for
4.14 resale to a person for use within the state from any person not licensed as a manufacturer
4.15 under section 349.163, except for gambling equipment returned from an organization
4.16 licensed under section 349.16, or exempt or excluded from licensing under section
4.17 349.166.

4.18 (i) No distributor or distributor salesperson may sell gambling equipment, except
4.19 gambling equipment identified as a promotional ticket, to any person for use in Minnesota
4.20 other than (i) a licensed organization or organization excluded or exempt from licensing,
4.21 or (ii) the governing body of an Indian tribe.

4.22 (j) No distributor or distributor salesperson may sell or otherwise provide a pull-tab
4.23 or tipboard deal with the symbol required by section 349.163, subdivision 5, paragraph
4.24 (d), visible on the flare to any person other than in Minnesota to a licensed organization or
4.25 organization exempt from licensing.

4.27 **349.1641 LICENSES; SUMMARY SUSPENSION.**

4.28 The board may (1) summarily suspend the license of an organization that is more
4.29 than three months late in filing a tax return or in paying a tax required under chapter 297E
4.30 and may keep the suspension in effect until all required returns are filed and required taxes
4.31 are paid; ~~and~~ (2) summarily suspend for not more than 90 days any license issued by the
4.32 board or director for what the board determines are actions detrimental to the integrity
4.33 of lawful gambling in Minnesota; and (3) summarily suspend the license of a gambling
4.34 manager who has failed to receive the training required under section 349.167, subdivision

5.10 When an organization's license is suspended under this section, the board shall within
5.11 three days notify all municipalities in which the organization's gambling premises are
5.12 located and all licensed distributors in the state.

5.14 Subd. 2. **Gambling managers; licenses.** A person may not serve as a gambling
5.15 manager for an organization unless the person possesses a valid gambling manager's
5.16 license issued by the board. In addition to the disqualifications in section 349.155,
5.17 subdivision 3, the board may not issue a gambling manager's license to a person applying
5.18 for the license who:

5.19 (1) has not complied with subdivision 4, ~~clause~~ clauses (1) and (2);

5.20 (2) within the five years before the date of the license application, has committed
5.21 a violation of law or board rule that resulted in the revocation of a license issued by the
5.22 board;

5.23 (3) has ever been convicted of a criminal violation involving fraud, theft, tax

6.24 Subd. 7. **Gambling manager examination.** Each applicant for a new gambling
6.25 manager's license, ~~and each renewing applicant that has failed to receive training as~~
6.26 ~~required in subdivision 4~~, must pass an examination prepared and administered by the
6.27 board that tests the applicant's knowledge of the responsibilities of gambling managers,
6.28 and of gambling procedures, laws, and rules before being issued the license. In the case of
6.29 the death, disability, resignation, or termination of a gambling manager, a replacement
6.30 gambling manager must pass the examination within 90 days of being issued a gambling
6.31 manager's license. The board shall revoke the replacement gambling manager's license

7.34 of the premises permit and must expire on the same day that the premises permit expires.

8.5 gambling. The lease must authorize the continued tenancy of the organization without

8.9 on the amount of rent which an organization may pay to a lessor for premises leased for

8.16 operations where both a pull-tab dispensing device is located and a bar operation is also

8.18 (i) in any month where the organization's gross profit at those premises does not
8.19 exceed \$4,000, up to \$400; and

8.20 (ii) in any month where the organization's gross profit at those premises exceeds
8.21 \$4,000, up to \$400 plus not more than ten percent of the gross profit for that month in
8.22 excess of \$4,000;

8.23 (2) for bar operations, including bar operations where a pull-tab dispensing device
8.24 is located but not including bar operations subject to clause (1), and for locations where
8.25 only a pull-tab dispensing device is located:

8.26 (i) in any month where the organization's gross profit at those premises does not
8.27 exceed \$1,000, up to \$200; and

8.29 \$1,000, up to \$200 plus not more than 20 percent of the gross profit for that month
8.30 in excess of \$1,000;

8.31 (3) a lease not governed by clauses (1) and (2) must be approved by the board
8.32 before becoming effective;

8.33 (4) total rent paid to a lessor from all organizations from leases governed by clause
8.34 (1) may not exceed \$1,750 per month. Total rent paid to a lessor from all organizations
8.35 from leases governed by clause (2) may not exceed \$2,500 per month.

9.1 (c) Rent paid by an organization for leased premises for the conduct of bingo is
9.2 subject to either of the following limits at the option of the parties to the lease:

9.3 (1) not more than ten percent of the monthly gross profit from all lawful gambling
9.4 activities held during bingo occasions excluding bar bingo or at a rate based on a cost per
9.5 square foot not to exceed 110 percent of a comparable cost per square foot for leased space
9.6 as approved by the director; and

9.7 (2) no rent may be paid for bar bingo.

9.8 (d) Amounts paid as rent under leases are all-inclusive. No other services or
9.9 expenses provided or contracted by the lessor may be paid by the organization, including,
9.10 but not limited to, trash removal, janitorial and cleaning services, snow removal, lawn
9.11 services, electricity, heat, security, security monitoring, storage, other utilities or services,
9.12 and, in the case of bar operations, cash shortages, unless approved by the director. Any
9.13 other expenditure made by an organization that is related to a leased premises must be
9.14 approved by the director. An organization may not provide any compensation or thing of
9.15 value to a lessor or the lessor's employees from any fund source other than its gambling
9.16 account. Rent payments may not be made to an individual.

9.17 (e) Notwithstanding paragraph (b), an organization may pay a lessor for food or
9.18 beverages or meeting room rental if the charge made is comparable to similar charges
9.19 made to other individuals or groups.

9.20 (f) No entity other than the licensed organization may conduct any activity within
9.21 a booth operation on a leased premises.

9.22 (g) Employees of a lessor not involved in the conduct of lawful gambling on the
9.23 premises or nongambling employees of an organization conducting lawful gambling on
9.24 the premises may participate in lawful gambling on the premises provided if pull-tabs or
9.25 tipboards are sold, the organization posts the major prizes awarded.

9.26 (h) A gambling employee may purchase pull-tabs or tipboards at the site of the
9.27 employee's place of employment provided:

9.28 (1) the organization posts the major prizes for pull-tab or tipboard games; and

9.29 (2) the employee is not involved in the sale of pull-tabs or tipboards at that site.

9.30 (i) At a leased site where an organization uses a paddlewheel consisting of ~~30~~ 32
9.31 numbers or less or a tipboard consisting of ~~30~~ 32 tickets or less, tickets may be sold
9.32 throughout the permitted premises, but winning tickets must be redeemed, the paddlewheel
9.33 must be located, and the tipboard seal must be opened within the leased premises.

10.1 Subd. 10. **Pull-tab records.** (a) The board shall by rule require a licensed
10.2 organization to require each winner of a pull-tab prize of \$50 or more to present
10.3 identification in the form of a driver's license, Minnesota identification card, or other
10.4 identification the board deems sufficient to allow the identification and tracing of the
10.5 winner. The rule must require the organization to retain winning pull-tabs of \$50 or more,
10.6 and the identification of the winner of the pull-tab, for 3-1/2 years.

10.7 (b) An organization must maintain separate cash banks for each deal of pull-tabs
10.8 unless (1) ~~two or more deals are commingled in the licensed organization uses~~ a pull-tab

10.23 linked bingo game provider must notify the board in writing of the delinquency on the
10.24 next business day.

10.25 (b) If a distributor or linked bingo game provider who has notified the board under
10.26 paragraph (a) has not received payment in full from the organization within 60 days of the
10.27 notification under paragraph (a), the distributor or linked bingo game provider must notify

11.5 Subd. 1b. **Credit and sales to delinquent distributors.** (a) If a manufacturer does
11.6 not receive payment in full from a distributor within ~~35~~ 30 days of the day immediately
11.7 following the date of invoice, the manufacturer must notify the board in writing of the
11.8 delinquency on the next business day.

11.9 (b) If a manufacturer who has notified the board under paragraph (a) has not received
11.10 payment in full from the distributor within 60 days of the notification under paragraph (a),
11.11 the manufacturer must notify the board of the continuing delinquency.
